

## **Governance Reforms**



Australian Red Cross Society February 2025

On 14 February 2025, the National Council of Australian Red Cross Society approved comprehensive changes that ensure our new governance structure:

- $\checkmark$  Is contemporary and fit for purpose.
- ✓ Aligns with the requirements of the International Red Cross and Red Crescent Movement.
- ✓ Will support Australian Red Cross in achieving its vision and purpose for another 110 years.

These governance reforms are a significant development for Australian Red Cross, as it will help our National Council, Board, and Division Councils operate in a more efficient and effective way, so they can better support all Australian Red Cross People in performing our vital role as part of the world's largest humanitarian network.

The changes follow a comprehensive review process over the last four years, which included consultation with Governance Members of Australian Red Cross, Divisional Advisory Boards, the Department of Prime Minister & Cabinet, the Joint Statutes Commission of the International Federation of Red Cross & Red Crescent Societies (IFRC) and International Committee of the Red Cross (ICRC), other National Red Cross & Red Crescent Societies, and other Australian member-based organisations.

Our new governance structure is anticipated to be effective from 1 July 2025 (subject to approval by Australia's Governor-General).
